INTERIM SUPERINTENDENT'S REPORT


Dr. Alvarez made several comments related to the reopening of schools including discussion of timeline and preparation leading to the Restart Plan and school reopening on September 3; presentation of data regarding the number of River Vale students attending in-person instruction vs. remote-only learners; development of the school calendar for the first trimester, and the possibility of changes to the calendar in the near future; addition of staffing as a result (3 permanent substitutes and 1 nurse); and report on the number of Bergen County districts going remote at this time--fewer than 15%.

Kimberly Dowling, Supervisor of Curriculum, Instruction and Assessment, continued presenting available parent resources and information, as well as shared photographs of modifications to hallways, classrooms, and other instructional spaces to accommodate social distancing guidelines.

BOARD SECRETARY'S REPORT

Ms. Ippolito spoke to the question raised about the Local School District – K-8 River Vale comprising 42.44% of the total property taxes paid annually.

"The difference from 2019 to 2020 in the Municipal Budget is an increase of \$70.26 on an average home assessed at \$592,000.

Net Assessed Valuations

The tax levy cap for school districts is set at 2.00% unless specific criteria are met which would allow for an increase over 2.00%. The River Vale Board of Education has subscribed to a financially prudent philosophy that includes being fiscally responsible and respectful to the community while maintaining the best quality education for the children of River Vale. The River Vale Board of Education has stayed below the 2.00% tax levy cap since 2014-2015.

While there are provisions in the law to provide for school districts to incur banked cap, which allows for raising the tax levy cap over the 2.00% without voter approval, the River Vale Board of Education has been committed to its fiscal conservatism and living within its means. To that end, the River Vale Board of Education has allowed \$360,846 in banked cap to expire based on the fact that their budgets where able to be prepared with all of the educational, technology and facilities needs included within the 2.00% tax levy cap.

Governor Murphy's Executive Order 177

December 2020 special school elections pursuant to N.J.S.A. 19:60-2(a) shall be suspended until the authorized January 2021 special school election date. No special elections to fill any vacancies shall be held prior to January 12, 2021. This Order shall take effect immediately.

Some questions from the public were asked prior to this meeting. There are as follows:

- 1. Will there be clear plexiglass around students' desks? Plexiglass dividers are being used in the classrooms and areas that have tables vs. desks that can be physically separated six (6) feet.
- 2. Are our schools changing their filter HEPA systems to cover not just allergens but also bacteria/viruses to circulate air from outside instead of just inside? We have engaged a vendor to provide us with a quote on installing needlepoint bi-polarization systems in our schools. We must abide by the Public Contract law and follow the prescribed regulations in purchasing supplies, equipment and materials. This installation would be in all classrooms as well as the rooftop units and would be a major undertaking. The cost of this project exceeds a purchase that can be made without Board approval and it requires a Notice of Intent to Award to be posted 10 days in advance of the award. To that end, the quote was just received last week and the goal is to place this contract award on the September 8, 2020 Board agenda. It is important to understand that there is a great demand for systems such as this and there may be a delay in not only securing the products but also the vendor's availability to install the systems.
- 3. If I understand this correctly, the new code is now requiring to have 100% fresh air and our schools are not providing that. So how can our schools open without being up to code. By code, we were required to bring in 20% of outside air into the building. That has now been increased to 100% outside air must be brought into the buildings, utilizing either windows or building mechanicals such as rooftop units, which pull the outside air through the system and into the unit ventilators that are in each classroom. Our building mechanicals are fully capable of complying with this requirement.

Regarding **portable ac units- not window units-** that plug in and can provide a bit of relief for our teachers and students.

Are parents permitted to chip in to purchase these units for their kids and teachers if the administration is not?

We appreciate you interest and concern. The portable AC units that you would like to donate would not be permissible as there is still not enough capacity in the electrical panel to provide electricity to the individual units in each classroom. Also, due to the new regulations that require

the district bring in 100% outside air, this portable AC unit would never be able to handle cooling the classroom. They are rated for a room of up to 700 sq. ft. and most of our classrooms are near 900 sq. ft. It is certainly a nice gesture however not going to be effective.

Ms. Ippolito stated that questions regarding ventilation and air conditioning have been raised. One of which is why wait for a referendum? Why vote on improvements?

Ms. Ippolito led the discussion with providing background information as follows: Currently there is Debt service aid still available to districts

What is a Bond Referendum?

It's a vote (referendum) in which the school district seeks permission to borrow (through the sale of bonds).

Schools use this method strategically to manage large-scale improvements, but not just because it spreads out payments similar to the way a consumer uses a car loan or mortgage. When voters approve a bond referendum, qualified projects are eligible for up to 40% in state funding called debt service aid. Paying for those projects with the regular budget means local taxes cover 100% of the costs. Plus, it would take many more years to pay for the project through the regular budget alone – without any support from state aid. There are only five (5) times a year that you can go to the voters for permission to borrow money through the sale of bonds.

Ms. Ippolito spoke to the following

1. Funding of Project(s) Identified

- a. Operating Budget
- b. Capital and Maintenance Reserve
- c. Second Question
- d. Bond Referendum

2. Advantages of a Bond Referendum:

- a. Debt Service Aid (DSA) is still available for eligible projects for up to 40%. Average DSA typically is 34%.
- b. Spread the cost over 20 years and continue the same if not less than the current debt which is due to end in 2021.
- c. Referendum question can be separated into multiple questions.

3. Timeline For Referendum

- a. The board of education of a Type II (elected) school district may call a special election as follows:
 - i. The fourth Tuesday in January
 - ii. The second Tuesday in March
 - iii. The last Tuesday in September
 - iv. The second Tuesday in December
 - v. When in its judgment the interests of the schools require it. N.J.S.A. 19:60-2.

For 2020, the following Tuesdays are the dates for special elections: January 28, March 10, September 29, and December 8. (Postponed by Executive Order 177).

From Noelle Grskovic, 712 Westwood Avenue: Why are surrounding towns making accommodations for K and 1st grade for more in school accommodations ... how do you expect a Kindergarten student to sit in front of a computer; how is the working parent supposed to sit with them ... and why does Cohort A go a week less then B?

Dr. Alvarez responded that the intent was for equity and consistency for parents. The Cohorts do balance by the end of the trimester however; I will review the concerns with the Administration.

From Jamie Alexander, 510 Dorchester Drive: Attendance is capped at 100 people; there are people who cannot join - can the limit be increased?

Ms. Ippolito responded that the current setting for the number of participants can be increased for the future however not in the middle of the current meeting. Based on the previous Zoom meetings held since March the 100 participants was not an issue. Previous meetings were not well attended.

From Melissa: If your commitment is to our children then they all should have equal time in school. The schedule you sent out is very unbalanced. Why is the schedule so unbalanced?

Dr. Alvarez responded that the intent was for equity and consistency for parents. The Cohorts do balance by the end of the trimester however; I will review the concerns with the Administration.

From Valerie Steiner, 615 Poplar Road: The meeting is limited to 100 people parents cannot get in.

Ms. Ippolito responded that the current setting for the number of participants can be increased for the future however not in the middle of the current meeting. Based on the previous Zoom meetings held since March the 100 participants was not an issue. Previous meetings were not well attended.

From Valerie Steiner, 615 Poplar Road: This meeting violates open meetings.

Ms. Ippolito responded. This is an incorrect statement. The current setting for the number of participants can be increased for the future however not in the middle of the current meeting. Based on the previous Zoom meetings held since March the 100 participants was not an issue. Previous meetings were not well attended.

From Jamie Alexander, 510 Dorchester Drive: 40% of our taxes go to the school system and it's not working for a good percentage of the town.

From Jaime Biegel, 710 Wilson Court: Has the River Vale reopening plan been approved by the governor at this time?

Dr. Alvarez responded that School Districts are required to submit their reopening plans to the County Offices for review. The Governor does not approve the plans.

From Nicole Chamberlain, 545 Baylor Avenue: My comment is in regard to the Restart plan. There appears to be an inequitable number of face-to-face days between the cohorts. Cohort A is face-to-face for 12 days. Cohort B is face-to-face for 17 days. That's a full five school days difference. The restart plan is intentionally fluid and flexible, and I'm curious.

From Nicole Chamberlain, 545 Baylor Avenue: If the district would revise this schedule so that both face-to-face cohorts would have equitable time. An easy fix is to use the Wednesday 9/30 and 10/14 as cohort A days so each cohort would go 2 days that week.

Dr. Alvarez responded this was asked and will be reviewed.

From Samantha Hannigan, 507 Alosio Drive: I would like to better understand how the A/B schedule was determined? It is very unbalanced with A having 5 less days in school which does not seem to be in the best interest of the children.

Dr. Alvarez responded this was asked and will be reviewed.

From Melissa: Kids should be able to meet their teachers before school.

Dr. Alvarez responded this was a possibility and will be discussed with the Administrators.

From Julia Geffner, 557 Barr Court: I would also like to understand how you plan to bring in FRESH air into the classrooms.

Ms. Ippolito responded that the District has ventilation systems in all the schools which bring in outside air to every room.

From Marla Giummarra, 790 Drake Lane: Can you advise re: temperature in the rooms? In the past when it reached a certain degree the children were sent home. Will this be the case this year and if so at what temperature that go into effect?

Ms. Ippolito responded that the temperatures will be monitored and humidity plays a role in the comfort of a room also. An 85 degree day with no humidity is not the same as a few humid days in a row followed by a humid day at 77 degrees. Students will also be dismissed according to the modified schedule.

From Karen Kramer, 307 Alpine Circle: I would like to know if there will be transparency of COVID cases; and if a teacher or student has it, will everyone in the school be quarantined or just the class?

Dr. Alvarez responded that the District will be following CDC and Department of Health guidelines.

From Holly Schepisi, 757 Tiffany Avenue: To what extent are we receiving guidance from the Bergen County Superintendent and NJ DOE with respect to the fully remote data? What portion of those days will be zoom meetings as opposed to "self-taught"? Many parents are exploring hiring supplemental pod type models out of concerns for learning based upon the spring model.

For working parents with younger children the spring was a bit of a disaster. Trying to plan for what the fall plan may be.

Ms. Dowling responded that lessons were learned from the spring and a rigorous schedule was carefully developed (see website for more information) to provide a solid educational plan until such time as students are back full time in person.

From Bridget Grant, 36 Bock Drive: How many people and or classrooms will need to be exposed to Covid before the school goes fully virtual?

Dr. Alvarez responded that the State sent out guidance for school districts to follow.

From Marla Giummarra, 790 Drake Lane: There are way too many links... the district needs to streamline this and keep it simple. This is overwhelming for the parents and children. This should be a lessoned learned from last year.

Dr. Alvarez thanked Ms. Giummarra for her comment.

From Enza Sardella, 665 Woodside Avenue: When will students learning remotely have an opportunity to engage with their teacher?

Dr. Alvarez responded yes.

From Carmen Martin, 635 Maple Street: In reference to the ventilation system can you explain why the district is not using the recommended MERV 13 filters?

Ms. Ippolito responded. The District's filters are MERV 8 which are the manufacturer's recommendation. Using a MERV 13 filter when not the recommendation would result in the equipment being over stressed to bring outside air thru the system and causing the equipment to fail.

From Valerie Steiner, 615 Poplar Road: Did the state accept our plan yet?

Dr. Alvarez stated he did sign the Governor's assentation and the teachers have been provided the appropriate professional development.

From Bridget Grant, 36 Bock Drive: Why haven't tents been purchased for our schools but in other district such as Old Tappan they have been? The children should be out door as much as possible. I hear "safety" is the issue. Please respond with what safety is the concern that would be more important than the health of the children?

Dr. Alvarez responded that the District is not using tents for outdoor teaching however, teachers may take students outside depending on the lessons.

From Carmen Martin, 635 Maple Street: Can you provide an update on the price quote for installing needle point bi-polarization systems in the schools.

Ms. Ippolito responded that the District must follow the Public Contract Law and is set to award the contract for the purchase and installation of the needle point bipolar ionization systems in each school in the amount of \$217,834 at the September 8th Board meeting.

From Cheryl Berkowitz, 570 Wayne Drive: What kind of training have the teachers gone through for remote learning other than tutorial; and what will grading look like for the middle school?

Ms. Dowling responded that the teachers will continue to receive professional development as is the District's practice.

From Melissa: Group A and group B should also share the first week of school. Group A goes Thursday Group B on Friday.

From Amy Dahl, 608 Abbe Court: Will teachers be supplied with PPE.

Ms. Ippolito responded. The River Vale Public Schools has purchased additional masks for students and staff; however, we are asking that all families and staff members provide their own face covering(s). We recognize that students and staff might have a preference and want everyone to be as comfortable as possible when at school. Please note that students and staff who choose to wear a face shield MUST also wear a mask. The River Vale Public Schools purchased face shields for all staff members. All schools will be equipped with additional masks for both students and staff.

From Rachel Galatt, 421 Margiasso Court: What does the filter actually filter? There is a chart that details this and would be good to understand if the manufacturer filters do anything

Ms. Ippolito responded. The District's filters are MERV 8 which are the manufacturer's recommendation. (Chart on the FAQs)

From Amy Dahl, 608 Abbe Court: Is there a maximum temp that is allowed for the children to be in the classroom? Will room temps be monitored?

Ms. Ippolito responded that the classroom temperatures are monitored daily. Temperatures and humidly will both be factors in deciding if the rooms are too hot to be occupied.

From Edward Salib, 562 Faletti Way: What specific cleaners/disinfectants are being used to sanitize? Same for the foggers? Are these tested chemicals done by trained professionals? Ms. Ippolito responded that the disinfecting of classrooms and high touch areas is done by the custodians. The specific cleaners and disinfectants are on in the FAQs for the reopening plan on the District website.

From Melissa: Also why can't we schedule outdoor meetings with the teachers for the kids? before school. These are easy fixes.

Dr. Alvarez stated that he would be discussing this with the Administrators tomorrow.

From Marla Giummarra, 790 Drake Lane: Yes, what does the manufacturers filter do? Can you properly spec the filters? Please explain what rooms the ion filters will be in?

Ms. Ippolito stated that the manufactures filters are appropriate for schools and all rooms will have the needle point bipolar ionization equipment.

From Bridget Grant, 36 Bock Drive: The Cohorts should be split as even as possible for the first four weeks considering most colleges have already opened and shut in a matter of weeks. The answer should not be the schedules will even out by November (flu/cold season).

Dr. Alvarez responded this was asked and will be reviewed.

From Amy Dahl, 608 Abbe Court: Do we have the capability for not only drawing in air but also forcing air out?

Ms. Ippolito stated the building ventilation system provides for outside air to be exchanged for the air that is in the room dissipating the C02 build up.

From Jaime Biegel, 710 Wilson Court: Has the plan been approved by the governor? Have you or will you sign the governor's attestation prior to the teachers return? Will the teachers be given professional development on this new learning prior to the start of the school year?

Dr. Alvarez stated he did sign the Governor's assentation and the teachers have been provided the appropriate professional development and it will be on going.

From Jamie Alexander, 510 Dorchester Drive: What training/support have teachers received to accommodate the simultaneous in-person and remote learning plans for September?

Ms. Dowling stated that new software was purchased and the teachers will be provided professional development prior to the start of school and throughout the year.

From Julia Geffner, 557 Barr Court: Asking on behalf of someone not able to get on the zoom. Why did participants on the restart and implementation committees not get a say or get to participate but only check a box. This was supposed to be an inclusive process but the committee of parents seemed to be silenced. What was the process there and what was their role?

Dr. Alvarez stated that the process did allow for input not only in the restart meeting but through email as well, which he said he had received many emails providing feedback.

From Valerie Steiner, 615 Poplar Road: We were told that kids would be logging in and out throughout the day, as opposed to just staying logged in for the day. Why.

Ms. Dowling responded.

From Rachel Galatt, 421 Margiasso Court: What is the training that is occurring for our teachers to ensure they are comfortable and confident with any new technology and Covid 19 protocols occurring in schools?

Ms. Dowling stated that the teachers have and will have the appropriate professional development not only starting the year but throughout.

From Mario Blanch, Valerie Blanch, 615 Poplar Road: What is the training that is occurring for our teachers to ensure they are comfortable and confident with any new technology and Covid 19 protocols occurring in schools.

Ms. Dowling stated that the teachers have and will have the appropriate professional development not only starting the year but throughout.

From Rosalie Boothe, 327 Spring Street: What happens if the referendum does not pass in January? Our schools still need air conditioning! What can we do to inform the people of River Vale so they can vote yes? Thank you

Ms. Ippolito stated that should the referendum not pass in January there is a date in March that the Board could go back out to the voters. The Board is assembling a communications committee to get the information out to voters.

From Valerie Steiner, 615 Poplar Road: Was plan accepted by the state

Dr. Alvarez stated he did sign the Governor's assentation

From Rachel Galatt, 421 Margiasso Court: The restart committee never discussed K/1 plans nor were we presented an option to have them go 5 days per week!

Dr. Alvarez stated that option was absolutely presented.

From Michele Ortiz, 564 Roosevelt Avenue: I have an incoming Kindergartner, second grader, and fourth grader. I know this is a challenging time but I need to share concerns tonight that I and other parents I know are feeling. I know it was a challenging task to create a schedule that is best for all our students and families. With that being said, I'm disappointed that the administration could not find a way for grades K&1 to have in-person half day instruction every day. Grades K&1 are vital developmental years in a child's education and certain skills like imaginative play, social skills, can only be learned in a classroom environment. It is almost impossible for a 5/6 year old to have a long enough attention span when staring at a computer for hours. Most if not all surrounding districts including Hillsdale made a few slight changes to make this happen. I'm disappointed that our district did not try to make this happen. Why can't we use specials, Art, music classrooms (since these won't be used) to add additional classes? I know that in second grade there are only two sections. The extra classroom and teacher from second grade could have been used for a Kindergarten class. What is that classroom being used for? The class sizes are all much smaller now, then why couldn't we move an interventionist into a classroom teaching position. I am also speaking tonight regarding the inequality of in-

person education in our district between Cohort A and cohort B. September/October are the most important months of a child's school year especially a kindergartner who is just starting out for the first time in a new school. It's an important time to build the foundation for the school year; the students to get to know their teacher, build relationships, and a sense of school community. It is unfair that one cohort will have this advantage over the other. I don't know how you can expect these cohort A and remote learning students to begin virtual learning without having even met their teacher? Especially a scared new kindergartner. I'm disappointed that the district didn't take this into consideration. Please consider changing the schedule to meet the needs of All your students. Thank you

Dr. Alvarez said thank you for your comments and we will be discussing these issues with the Administrators tomorrow.

From Michele Ortiz, 564 Roosevelt Avenue: Can we please have students in cohort A and remote learning students be able to meet their teacher when they pick up their laptops before virtual learning?

Dr. Alvarez stated that he would be meeting with the Administrators tomorrow and this shall be discussed.

From Amy Dahl, 608 Abbe Court: How will IEP's be adjusted for remote learning?

Dr. Alvarez stated that you should reach out to your case manager or Ms. DeGaetano for the specifics.

From Karen Kramer, 307 Alpine Circle: Is Holdrum live streaming like elementary?

Ms. Dowling stated yes.

From Amy Dahl, 608 Abbe Court: How will remote/non on campus kids ask a question during the actual lesson or do they need to wait until the afternoon?

Dr. Alvarez indicated that the teacher would incorporate this into the lessons as appropriate.

Ms. Ippolito stated that the District has continued to improve our technology and is comfortable moving forward with the livestreaming.

From Jaime Biegel, 710 Wilson Court: In the past, the nurse has not been available at all times. Will this change?

Ms. Ippolito stated the District has hired a substitute nurse/nurse's aide that will assist and if need be the District will contract with a third party nursing service should there be a need.

From Jacqueline Tovar, 215 Highland Street: Can a parent switch their child in the Elementary/Holdrum schools and switch them to 100% remote at any point during the school year. The high school is allowing hybrid students to become remote at any time a parent doesn't feel comfortable sending them hybrid?

Dr. Alvarez responded yes.

From Jamie Assor, 512 Bernita Drive: What happens if parents/sibling contract Covid? Does that impact the classroom to be shut down because of possible exposure, or even if family members of teachers contract it? Will the classroom be made virtual?

Dr. Alvarez stated that the District will be following the CDC and Department of Health protocols as directed.

From Heather Wider, 564 Egan Terrace: How many students will be in each class? Specifically for Kindergarten.

Dr. Alvarez stated the numbers were small. Anywhere from 6-9 students depending on the cohort.

From Edward Salib, 562 Faletti Way: There have been 0 new Covid cases in River Vale in 2 months (as of 8/14). This is according to the Bergen DOH site. (https://www.co.bergen.nj.us/health-promotion/2019-novel-corona-virus),

Dr. Alvarez said "Thank you for your comment".

From Jacqueline Tovar, 215 Highland Street: Are children still going to have snack time?

Ms. Dowling responded that the Principals are working with the teachers to incorporate snack time with perhaps a mindful walk or activity.

From Marla Giummarra, 790 Drake Lane: Can you revisit outdoor learning as this is what NYC is doing? If they can figure it out for 100 plus school districts you should be able to as well. We have more money and certainly more space.

Dr. Alvarez stated that the District is not looking to revisit outdoor learning at this time.

From Jaime Biegel, 710 Wilson Court: Teachers need to be provided time. It cannot be expected that they will do this this summer. Resources is not training. Is there any talk about bumping the kids reporting to after Labor Day?

Dr. Alvarez stated that he was meeting with the Administrators tomorrow and it would be discussed.

From Lisa Starobinksy, 605 Kennedy Court: Will the kids have the opportunity to remove their masks for fresh air, especially when classroom temps may be very warm?

Ms. Dowling responded. Elementary students will have a 10-15 minute outside break, weather permitting, or in the classroom being socially distant.

From Rachel Galatt, 421 Margiasso Court: Why are other districts delaying open date to train teachers in person and we do not find it important enough to help ensure they are comfortable and confident? Tutorials are not enough.

Dr. Alvarez responded this was previously asked and answered.

From Mary Beth Mulry, 695 Alden Court: Can you please comment on mask breaks, snack & water breaks in the Middle school. Concerned about going from 7:30 (on bus) to 1pm (off bus)? Thank you.

Ms. Dowling responded. We do not offer snack at the middle school. Whenever possible, we are trying to make sure that they have mask breaks. We will be providing this during PE and other times when PE is not offered.

From Joanne Wells, 45 Mark Lane: Can someone explain how the grading will be done.

Ms. Dowling explained.

From Marla Giummarra, 790 Drake Lane: Can you please answer what is the temperature that is considered too hot? Please elaborate.

Ms. Ippolito explained that there are many factors involved with the rooms being considered too hot. The temperatures will be monitored as well as the students and staff regularly.

From Carmen Martin, 635 Maple Street: Several districts are returning to school after Labor Day to allow teachers and staff more professional training. Why are River Vale students returning to schools next week?

Dr. Alvarez stated that this was asked and answered earlier.

From Marla Giummarra, 790 Drake Lane: When are you looking to do the ionization filters by? Will this be done by the first day of school?

Ms. Ippolito reiterated that the Board will be approving the purchase at the September 8, 2020 Board Meeting. Hopefully the vendor has the items in stock and is able to start working ASAP. This will not be in for September 3rd.

From Kate Dalton, 695 Wicklow Way: What is specifically being done to adjust for students with IEPs?

Dr. Alvarez stated to contact your case manager or Ms. DeGaetano.

From Christopher Pinto, 564 Central Avenue: The Attestation for Reopening of schools certifies that the school district satisfies the 20-21 criteria for reopening. Many superintendents have to refused to sign. Will you be signing this form that certifies that you have reached the anticipated minimum standards set forth by the NJDOE?

Dr. Alvarez stated that he already signed the Governor's attestation.

From Cheryl Berkowitz, 570 Wayne Drive: If we don't have the proper filters to keep everyone safe from air contamination how can we open.

Ms. Ippolito stated the filters are proper and able to keep everyone safe. The District is seeking to enhance the ventilation in the near future.

From Bridget Grant, 36 Bock Drive: There are rumors of a teachers strike. What is the plan if that happens?

Dr. Alvarez indicated that he had not heard that.

From Edward Salib, 562 Faletti Way: Can you post the cut sheets for chemicals being used to sanitize and being used in the foggers on the FAQ site?

Ms. Ippolito stated yes.

From Bridget Grant, 36 Bock Drive: I find it difficult to understand why allergies and insect bites is the answer for not pursuing tents/outdoor learning. I think the risk of Covid-19 is a much larger threat to our students. Hasn't the student body always been exposed to the great outdoors during PE, recess, field day etc.?

Dr. Alvarez said that the District is not looking into outside learning at this time.

From Jaime Biegel, 710 Wilson Court: You said under the advice of your attorney, was it the governor's attestation signed or your attorney's modified version?

Dr. Alvarez stated that he already signed the Governor's attestation.

From Rachel Galatt, 421 Margiasso Court: Please advise when the teachers will get in person training. Again, many districts have delayed opening to do so diligently and ensure their staff are confident and comfortable and can master the technology that they are being asked to utilize to teach our kids. I would like a detailed answer to this and not glossed over. Thank you.

Ms. Dowling stated that this was asked and answered earlier.

From Valerie Steiner, 615 Poplar Road: Since the remote children will not be logged in during the work sessions, how will remote children be evaluated?

Ms. Dowling responded.

From Randi Ciancio, 505 Dorchester Drive: Can assignments on home days be allowed to be handed in after school hours so parents have the opportunity to help their kids.

Dr. Alvarez stated that was a reasonable request and he would discuss this with the Administrators tomorrow.

From Jennifer Weber, 573 Green Lane: 5 1/2 days was never presented as an option during the restart committee meetings.

Dr. Alvarez stated that it was presented as an option.

From Valerie Steiner, 615 Poplar Road: Also are children going to receive grades this year, as opposed to asterisk.

Ms. Dowling responded.

From Elisha Fischbein, 403 Faletti Circle: What are the general class size going to be?

Dr. Alvarez indicated the classes would be small depending on the cohorts. 6-8 students in some cases.

From Amy Salib, 562 Faletti Way: If the students are spaced in the hallways (per your photos) to walk alongside the walls, won't that increase surfaces being touched in the hallways and multiple students touching the same areas? How will children be corrected for "undesired actions" like "touching things" in a way that doesn't affect their mental wellness. I'm concerned about the amount of "correcting" that will be done for generally age appropriate child behavior that is worrisome in COVID circumstances and how all the correcting will affect self-esteem, etc.

Ms. Dowling indicated that students movement is being limited and the District has hired a mental health professional to assist with the students mental wellness.

From Cathy Corcoran, 731 Westwood Avenue: What is happening to the specials, specifically the music program?

Ms. Dowling indicated that specials will be virtual at the end of the day for the elementary schools and during some periods in person at the middle school.

From Ann Marie Zihal, 731 Beechcrest: Will the school nurse administer rapid COVID tests if a student/teacher develops symptoms while in-person? If not, will the district provide guidance where to go to get tested? If a student has to quarantine, will they be allowed to log on remotely on their in-school days? Will it be interchangeable?

Dr. Alvarez stated that the District will not be administering tests and will be providing guidance in accordance with the CDC and Health Department guidance. Students at home certainly can log on remotely.

From Marnie Zansitis, 217 Cedar Lane: Are you confident the schools have enough bandwidth to support virtual learning?

Ms. Dowling stated yes.

From Elizabeth Sklerov, 305 Spring Street: Will live streams be staggered between classrooms so parents can help the younger children?

Ms. Dowling responded.

From Marla Giummarra, 790 Drake Lane: How are handling the substitute situation if a teacher is out sick? Are subs allowed to work in multiple schools?

Ms. Ippolito stated that the District is hiring a building based sub for each school and using preferred subs to limit people in the buildings.

From Tracie Volpe, 631 Long Hill Road: Will there be a phase 3 and if so, what is the timing for changing models for phase 3?

Dr. Alvarez stated that this is an on-going process and shall be reviewed should there be a need.

From Randi Ciancio, 505 Dorchester Drive: Has the district purchased proper equipment for live streaming? My understanding is that they are propping laptops on desks.

Ms. Dowling responded

From Alyssa Ellner, 561 Barr Court: If we choose to keep our child home one day due to heat or a personal situation, can they log on and be part of the virtual learning or are do they have to take a sick day?

Dr. Alvarez stated yes.

From Jamie Assor, 512 Bernita Drive: You mentioned how many kindergarten children there will be physically in each class at the same time. Can you share similar information for each of the grades?

Dr. Alvarez indicated that the class sizes were between 6-9 depending on the grade.

From Jacqueline Tovar, 215 Highland Street: When will the 2nd grade get their chrome books? Will there be anyone monitoring how the children are washing their hands when going to the restroom? Should the children take their own soap/sanitizers? Can the children wear mask shields instead of a mask?

Ms. Dowling indicated that the handing out of chrome books was being coordinated and will be discussed at the Administrative meeting tomorrow. Students will be reminded to wash their hands and masks must be worn even with a face shield.

From Mary Beth Mulry, 695 Alden Court: If a child is sick or parent suspects they coming down with something (common cold, Covid exposure and need to quarantine etc.), on a day they are to be in person, is it as simple as them joining virtually if they are well enough to participate in school?

Dr. Alvarez stated yes.

From Jennifer Weber, 573 Green Lane: I'm having trouble understanding how there are only 4-6 kids in person at a time in K classes. This is really the largest # of kids possible in person?

Dr. Alvarez indicated that this number is based on the cohorts and number of student staying home. This may change in phase 2 and it is important to assign the students to a teacher that they will be with all year.

From Patrizia Sanelli, 616 Abbe Court: Are there any methodologies or timeframe to assess learning gaps across all grades for the time student have been in a remote learning situation to where they should be now?

Ms. Dowling responded that they will be reviewing and monitoring the situation.

From Catherine Corcoran, 731 Westwood Avenue: What will happen to the Holdrum band and choral programs, and how will they work for remote students?

Dr. Alvarez stated that these types of programs may run however look very different for this fall.

From Jaime Biegel, 710 Wilson Court: How can teachers accurately assess (especially reading) while maintaining 6ft distance? If using the plexi glass, who is responsible for cleaning it?

Ms. Dowling responded.

From Lauren Reinmann, 551 Dale Court: For those children on complete remote learning, how will they receive the beginning of the year assessments that you described?

Ms. Dowling responded

From Marisa Knudsen, 279 Collignon Way: Will the live streaming be recorded? This way students can watch later in the day if the live schedule does not work for their family?

Dr. Alvarez stated that this would be discussed with the Administrators tomorrow.

From Catherine Corcoran, 731 Westwood Avenue: Can you walk us through a typical elementary day and a typical middle school day?

Ms. Dowling referred to the reopening plan that is on the District website and depicts a typical day.

From Jennifer Weber, 573 Green Lane: Can you explain the logic on intermingling cohorts with 1 teacher? If intent to minimize interaction of students, how does this help? Would it be easier to have 1 teacher 5 days with the same students and allow remote students to live stream, especially for K-1?

Dr. Alvarez indicated that the class was split into two sections therefore when students are back full time in person, the class is intact.

From Jaime Biegel, 710 Wilson Court: We can't expect teachers to disinfect the rooms.

Ms. Ippolito stated that the teachers are not expected to disinfect the rooms. They will have wipes and cleaning products to use should an accident or minor incident occur.

From Ann Marie Zihal, 731 Beechcrest: Will there be flexibility with assignment deadlines to help the families who work full-time?

Dr. Alvarez stated that was reasonable and would be brought up with the Administrators tomorrow.

From Valerie Steiner, 615 Poplar Road: Who are the remote learning teachers? Are these new teachers that have been hired or substitute teachers.

Dr. Alvarez stated that the remote teachers are current staff reassigned to the remote learners.

From Randi Ciancio, 505 Dorchester Drive: For middle school students, why are we using inperson time for subjects that can easily be done at home? Like world language and gym? It seems like a waste of limited in-person that can be devoted to core subjects.

Ms. Dowling stated that the Middle school schedule was a bit more complicated than the elementary school schedule and required some of the classes which are not core subjects to be taught in person to make the schedule work.

From Dana Porrazzo, 239 William Street: Hi. Will teachers have evening hours to accommodate communication from working parents who might not be able to help their kids during the day? Or will hours be limited to the school day?

Dr. Alvarez stated this was something he would discuss with the Administrators tomorrow.

From Cheryl Berkowitz, 570 Wayne Drive: Can you specify the training teachers have already gone through, and how many hours/what kind of training they will be receiving before school begins?

Dr. Alvarez stated that teachers received the appropriate amount of training and will continue to do so throughout the year.

From Dana Porrazzo, 239 William Street: Thank you

From Marla Giummarra, 790 Drake Lane: Do you have online assessments for reading?

Ms. Dowling responded that they did.

From Elise Dykowsk, 432 Margiasso Court: Will the remote children be able to opt back in to in person learning? How will that work if classroom numbers are at capacity?

Dr. Alvarez stated that we are asking parents to commit to Phase 1 and then if changes would like to be made, it's re-evaluated and changed at that time.

From Jennifer Weber, 573 Green Lane: Follow Up: if we can fit 10 kids in a room and the K class is 4 - 6 students, why not land at 10 kids 5 days a week with 1 teacher? If the teacher will be seeing the same children, why not have them there for the 5 days, especially K-1 while having class size within allowable limits?

Dr. Alvarez stated this was asked and answered previously

From Dana Porrazzo, 239 William Street: Hi again. Will club opportunities still take place in HMS as applicable? Thank you.

Dr. Alvarez indicated that this is the case.

From Paola Vallejo, 832 Rose Court: How do working parents accommodate their young children who are unable to type their questions to their teacher?

Ms. Dowling stated that there are many parent resources on the District website along with the restart plan.

From Nicole Brayton, 577 Hamilton Place: I understand that another nurse has been hired to cover all three schools. What happens in the event that coverage is needed in more than one school?

Ms. Ippolito indicated that should the need arise; the District will contract with a third party agency to provide nursing services as in the past.

From Sakina F. Dinani, 663 Rita Drive: Do we have a team in place to monitor if there is learning disparities between cohorts or remote learners over time?

Ms. Dowling indicated that this would be monitored.

From Lauren Reinmann, 551 Dale Court: For completely remote learners that do not see the homeroom teacher in person, is there a time they have 1:1 remote time to connect with the primary teacher? It sounds like the remote teacher is there main point of contact (other than live stream)

Ms. Dowling indicated that there would be time made available for this purpose.

From Elizabeth Sklerov, 305 Spring Street: Can you commit to staggering live stream for younger grades for parents who have kids in, for example, both K and 1 who need 1:1 computer help?

Ms. Dowling responded.

From Randi Ciancio, 505 Dorchester Drive: What happens if students miss live streams that have working parents? Will they be penalized?

Dr. Alvarez stated that the student would not be penalized and this will be brought up with the Administrators tomorrow.

From Paola Vallejo, 832 Rose Court: How do working parents accommodate their young children who are unable to type their questions to their teacher?

Ms. Dowling stated that this will be brought up with the Administrators tomorrow.

From Marzena Santos, 747 Rolling Hill Drive: Do you feel that full remote kids will get equal quality programming as f2f as guidelines read?

Ms. Dowling responded yes.

From Michelle Martino, 726 Tiffany Avenue: What accommodations are being made for special education students that should have in person support as dictated by their IEPs?

Dr. Alvarez responded that parents can reach out to their case workers or Ms. DeGaetano.

From Lauren Reinmann, 551 Dale Court: For children that are pulled out for services, will that occur during main subject times?

Ms. Dowling responded that pull out services will be scheduled not during main subject times as best as possible.

From Elyssa Sawyer, 774 Rolling Hill Drive: Who are the remote teachers? Classroom aides, new hires?

Dr. Alvarez responded that the remote teachers are River Vale teachers.

From Beth Tulino, 554 Green Lane: A cohort will start on 9/3 live stream?

Ms. Dowling responded that was correct.

From Sakina Dinani, 663 Rita Drive: If a student/staff member misses school for fever/illness: 1) are they required to be out 14 days; 2) must they provide a Covid test to return?

Dr. Alvarez responded that we are following all of the CDC protocols.

From Andrew Luciano, 568 Egan Terrace: This might have been asked already but are the remote teachers the same as the normal teachers?

Dr. Alvarez responded that is correct. Remote teachers are River Vale teachers.

From Michelle Martino, 726 Tiffany Avenue: Sorry if already asked - has the disproportionate days between A and B indicated in the calendar been discussed when it seems simple to give A some Wednesdays when a holiday falls on Monday?

Dr. Alvarez responded that was previously asked and answered.

From Kate Dalton, 695 Wicklow Way: It is my understanding that the only IEP students in the separate, individual classrooms are allowed for 5 days per week. Those with IEPs that are integrated in the general classroom must follow the assigned cohort. Is that correct?

Ms. Dowling responded that was correct. Dr. Alvarez responded that parents can reach out to their case workers or Ms. DeGaetano.

From Marzena Santos, 747 Rolling Hill Drive: This may have been asked already. Are you confident that we are meeting all the newer/updated codes 100% now?

Ms. Ippolito responded – Absolutely

From Beth Tulino, 554 Green Lane: What will you do to even out the cohort days?

Dr. Alvarez responded that was previously asked and answered.

From Catherine Corcoran, 731 Westwood Avenue: This may have been addressed. Since middle school students have unique schedules (different electives, languages, math levels, POG, etc.) will they be moving from room to room?

Ms. Dowling responded that the students in the middle school are going to be limited to changing classes as much as possible. Changing classes will be very limited.

From Kate Dalton, 695 Wicklow Way: Follow up question from above. For the IEP students that have a shared aide that are now only on campus in cohorts has there been any thought on how the aide will support on remote days?

Dr. Alvarez responded that parents can reach out to their case workers or Ms. DeGaetano.

From Marianne Grace: How will attendance be monitored for virtual learners?

Ms. Dowling responded. Students who are attending remote instruction will post attendance via Genesis, just as last year.

From Edward Salib, 562 Faletti Way: What specific metrics are the district or County/State DOE looking at to return to having all students back in classes 5 days a week?

Dr. Alvarez stated that the District would be looking for guidance from the CDC and Health Department.

From Kristin Rosenstein, 515 Forest Court: Thank you for answering all these questions. many - multiple times over and over. we appreciate the hard work you're putting into this and ensuring the parents have the CHOICE.
